This is for the information of all the students of this institution that **"RAGGING IS COGNIZABLE OFFENCE AND IS BANNED IN ANY FORM INSIDE & OUTSIDE THE CAMPUS"**.

As per the directions of Hon'ble Supreme Court of India, ragging in Educational Institutions in any form should be prevented. In order to ensure that the ragging does not take place in the Institution in any form, Anti Ragging Committee is hereby constituted which would conduct raids (including surprise raids) and detect the cases (if any) and suggest preventive measures.


Forms of Ragging	Punishments
<ul style="list-style-type: none">* Abetment to ragging;* Criminal conspiracy to rag;* Unlawful assembly and rioting while ragging;* Public nuisance created during ragging;* Violation of decency and morals through ragging;* Injury to body, causing hurt or grievous hurt;* Wrongful restraint;* Wrongful confinement;* Use of criminal force;* Assault as well as sexual offences or Un-natural offences;* Extortion;* Criminal trespass;* Offences against property;* Criminal intimidation;* Attempts to commit any or all of the above mentioned offences against the victim(s);	<ul style="list-style-type: none">* Cancellation of admission;* Suspension from attending classes and academic privileges;* With-holding/Withdrawing scholarship/ fellowship and other benefits;* Debarring from appearing in any test/ examination or other evaluation process;* With-holding of Results;* Debarring from representing the institution in any regional, national or in international meet, tournament etc.* Suspension/ expulsion from the hostel;* Rustication from the Institution for period ranging from 1 to 4 semesters;* Debarring from admission to any other institution for a specified period;

<ul style="list-style-type: none"> * Physical or psychological humiliation; * All other offences following from the definition of "Ragging". 	<ul style="list-style-type: none"> * Fine ranging between Rs.25,000/- to Rs.1.00 Lakh; * Rigorous imprisonment upto 3 years; * Collective punishment: When the persons committing or abetting the crime of ragging are not identified, the institution shall resort to collective punishment
